Sunol Glen has provided outreach to our community through staff meetings, School Site Council meetings, Employer-Employee-Relations Committee (E.E.R.C. - which consists of the administration, representatives from the Certificated Union, AFT, and the Classified Union, CSEA), Board meetings, and Town Halls which consisted of our teaching staff, classified staff, administration, families and the community at large as represented by our Board of Trustees to ascertain the areas of need to support our students' learning and to ensure resources were allocated accordingly. Based on the following facts, we are confident that all affected/interested groups have been included via our community engagement efforts:

- 1) Sunol is a small unincorporated community of 850 residents
- 2) Due to the small size of the population the community is close knit and everyone knows each other
- 3) The Superintendent has been with the District for over 14 years and is well known by the community
- 4) There are no organized civil rights or advocacy groups in Sunol
- 5) All of our communications with the parents are very personal so that we can ensure that we communicate in the language that the respective parents are most comfortable with

As the pandemic's impact on campus safety (COVID 19 guidelines), loss of instructional time and loss of learning; as well as, the concern for the social-emotional impact were a shared concern, the ESSR III Expenditure Plan provided targeted strategies, an increase in technology, and programs and support personnel to address these needs.

The input from the community was instrumental in developing our plan in that the priority consistent amongst the various stakeholders was about acclimating our students back into 'live/on campus' instruction and wanting to ensure that there were measures put into place to support our students. This consistency in feedback impacted decisions as to how to develop an expenditure plan in that much of the funds were spent on three major categories. First of all, funds were spent to provide cleaning supplies and Covid 19 preventative equipment (PPE) to reduce the spread of the virus on our campus. Another area was that funds were expensed in providing additional staffing so that we had more custodial oversight of our facilities - and more assistance in the classrooms to address individual student learning needs by effectively increasing the student to staff ratio - along with an increase in our technology devices to ensure all students have access to the core curriculum. And thirdly, by providing counseling support to address the social-emotional impact the pandemic has had on our students.

# ESSER III Expenditure Plan Instructions

## Introduction

A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Tracking student attendance and improving student engagement in distance education;
